To request a parking permit, visit [parking permits](#) and fill out the online form. The charging has been based on pay grades:

Band 1 to the top of Band 5 - £25 per year

Band 6 to the top of Band 9 - £75 per year

SM1 and upward - £150 per year

Tax-Free Childcare



You can get up to **£500** every 3 months (£2,000 a year) for each of your children to help with the cost of childcare.

If you get Tax-Free Childcare, the government will pay £2 for every £8 you pay your childcare provider through an online account. You can use it to pay for approved childcare.

You can get Tax-Free Childcare at the same time as 30 hours free childcare if you're eligible for both.
